

Course Requirements:	Exchange students are expected to take 20 IDC credits per semester of study. 20 IDC credits are equal to 15 credits at StFX. 4 IDC credits are equal to 3 credits at StFX.	
Course Restrictions:	StFX students are not able to register for Zell Entrepreneurship courses, Argov Fellowship courses, and Public Diplomacy courses: 4225, 4691, and 4516.

Cost:	\$360 - \$800 ILS per month. <i>*Not including water or electricity.</i> (Equivalent to approximately \$300 - \$460 CAD)
Details:	Reichman has 500 new, fully equipped residential units located in two 13-story tow- ers on the campus. However, rooms in the dormitories for exchange students are limited and placement is subject to availability on a first-come, first-served basis. Herzliya and Tel Aviv offer other great housing alternatives. Students may choose to look independently for other non-university related living arrangements (hous- ing suggestions will be included in the acceptance package).

OTHER COSTS	
Health Insurance:	All StFX students are required to purchase travel health insurance for the duration of their time abroad. Link Additionally, all IDC students are required to have comprehensive health insurance coverage throughout the period of their studies. Students can purchase private insurance or purchase the UMS Harel Yedidim insurance policy for international students, offered by Reichman. Our special arrangement with Harel Yedidim insurance company provides comprehensive health coverage for \$1,200 USD per academic year. Link
Living Expenses:	Link
Visa:	The majority of students, including those from the U.S., Canada, and most European countries may enter Israel on a tourist visa. The tourist visa is valid for three months from date of arrival and is issued free of charge at Ben-Gurion Airport. After three months, the visa must be extended for another three-month period at the Interior Ministry in Israel. You may extend your visa every three months for up to one year. A small fee is charged for each extension. Link
